Recommended Use of This Material and Restrictions of Use

This Standard Reference Material (SRM) is intended for the evaluation of analytical methods for the determination of elements in dietary supplement tablets and similar matrices and for quality assurance when assigning values to in-house control materials. A unit of SRM 3294 consists of five bottles, each containing 30 tablets. The SRM is delivered as whole tablets to provide stability since grinding may compromise this stability. Each tablet weighs approximately 1.5 g.

5. FIRE FIGHTING MEASURES

Fire and Explosion Hazards: Avoid generating dust. SRM 3294 is supplied in a small quantity and under normal laboratory conditions it does not constitute a combustible dust hazard. The physical properties of this material indicate that accumulated dust on surfaces generated where operations produce fine particulates may lead to combustible dust concentrations in air, and in the presence of an ignition source may present a potential hazard.

Extinguishing Media

Suitable: Regular dry chemical, carbon dioxide, water, or regular foam.

Unsuitable: None listed.

Specific Hazards Arising from the Chemical: None listed.

Special Protective Equipment and Precautions for Fire-Fighters: Move container from fire area if it can be done without personal risk. Avoid inhalation of material or combustion byproducts. Wear full protective clothing and NIOSH approved self-contained breathing apparatus (SCBA).
